## Membership

- Need to check accuracy of membership emails (i.e., whether they are current)
- Strip down the number of questions on the web site home page survey keep to just name, organization, and email address
- Can people join as members at general meetings? If so, we need to bring a printout of the membership application form to the general meeting next Thursday in Albany. Girk has this form.
- Need lists from Girk Cakmak or Paul Opel of current registered members of NYSGISA.
- Are Geospatial Summit attendees automatic members? A letter should be distributed to all registered inviting attendees to join the NYSGISA.
  - Should this be extended to out-of-staters? This may affect ability to meet NYSGISA quorum requirements for meetings.

# Geospatial Technology Camp

The Board continued discussing the possibility of a Geospatial Technology Camp. There has already been a "Career Camp" series offered through BOCES, which has included a week-long GeoSpatial camp program for 8<sup>th</sup> grade students several times. The program includes 4 days inside the lab and one day in the field. The NYSGISA may try to implement a 2-day overnight program at one pilot location in 2008.
