President Mickey Dietrich was unable to attend the Annual Meeting. President-Elect Reilly welcomed the membership and thanked them for attending the NYS GIS Association Annual Meeting. Treasurer's Report: Christa Hay, Treasurer

The Treasurer's Report dated October 20, 2016 was reviewed. The current balance is \$34,557.17. Major expenses for the year include website hosting and domain, regional conference sponsorships, D&O insurance, marketing and awards, and office and meeting expenses. To date there has been \$8,707.01 in income from membership dues, off-set by a \$2,806.57 loss at NYGeoCon. Estimated upcoming yearly operating expenses are approximately \$6,360.00, not including expenses for NYGeoCon or the GeoSpatial Summit.
